Re: Ratings of ORIX Leasing & Financial Services (OL&FS)

India Ratings (see definition below) communicates the following rating:-

- Long-Term Issuer Rating: 'IND AAA'; Outlook Stable
- Short-Term Issuer Rating: 'IND A1+'
- INR7.2bn (increased from INR3.2bn) non-convertible debentures: 'IND AAA'; Outlook Stable
- INR8.8bn (increased from INR7.7bn) bank loans (details in Annexure 1): 'IND AAA'; Outlook Stable




